HAWAI'I IS NOT A US STATE

HAWAI'I IS A SOVEREIGN NATION. THE PRETENSE OF U.S. LAW IN HAWAI'I IS THE SHAME OF THE U.S.A. THE ABSENCE OF RECONCILIATION AND INTERNATIONAL REDRESS IS THE SHAME OF EVERY ADMINISTRATION SINCE THE ISLAND NATION WAS DAMAGED IN 1893.

IN 1898 PRESIDENT MCKINLEY FLOUTED WELL DEVELOPED INTERNATIONAL LAW AND MANEUVERED TO PERMANENTLY OCCUPY THE KINGDOM OF HAWAI'I AND SUPPRESS IT'S PEOPLE. SINCE THEN THE U.S. HAS HEAVILY MILITARIZED HAWAI'I, TAKEN CONTROL OF THE PACIFIC AND BECOME AN IMPERIAL SUPERPOWER.

MCKINLEY PUSHED FOR THE ANNEXATION OF HAWAI'I AND CONGRESS PASSED THE 'NEWLANDS RESOLUTION' SUPPORTING A HANDFUL OF WHITE RACIST REBELS IN HAWAI'I WHO HAD EARLIER UNSEATED THE NATIVE HAWAIIAN MONARCH. THESE OPPORTUNISTS CONSPIRED THE INVASION OF U.S. TROOPS SEIZING IOLANI PALACE IN HONOLULU WHERE QUEEN LILI'UOKALANI WAS ON JANUARY 17, 1893.

DESPITE THE HISTORY OF U.S. PUBLIC STORYTELLING, THE **OVERTHROW, ANNEXATION AND STATEHOOD** HAVE NO LEGAL STANDING BECAUSE, OF COURSE, THE EXISTING TREATY OF FRIENDSHIP, COMMERCE AND NAVIGATION BETWEEN THE TWO NATIONS WAS NEVER AMENDED. WHY WOULD IT, THE QUEEN AND THE HAWAIIAN CITIZENRY NEVER AGREED TO U.S. OCCUPATION, THEY WERE OUTRAGED. THEY PROTESTED RESOLUTELY AND WITH DIGNITY, NEVER IMAGINING THAT THE U.S.A. WOULD NOT REPAIR THE DAMAGE AND WITHDRAW. U.S. CAPACITY FOR VIOLENCE AND GREED, AND ITS FUNDAMENTAL PRECEDENT OF DISREGARD FOR INTERNATIONAL LAW HAS BECOME ITS CONSTITUTION AND IS SELF-EVIDENT. ITS PROPENSITY FOR PRE-EMPTIVE STRIKE AND OCCUPATION HAS CREATED A BULLY MODEL THAT EXEMPLIFIES INDIFFERENCE FOR HUMAN RIGHTS, GLOBAL JUSTICE AND SUSTAINABILITY. YOU HAVE WITNESSED THINGS COLLAPSING ON THIS PLANET AND WITHOUT U.S. ACCOUNTABILITY IN HAWAI'I THE VERY KEYSTONES OF AN **OBAHMA ADMINISTRATION** ARE DANGEROUSLY EMPTY AND THE ABILITY OF THE U.S.A. TO VOLUNTARILY CHANGE IS UNREAL.

BE IT SHAMED SINCE THE U.S. "APOLOGY RESOLUTION", 1993, (DIRECTED TO NATIVE HAWAIIANS) THE STATE OF HAWAII MUST STILL ACKNOWLEDGE ITS 50TH STATEHOOD ANNIVERSARY THIS YEAR.
